## I. PLAN REVIEW SERVICE

- All plan reviews are normally completed within 10 business days for one set fee per project discipline. FSCI may need to extend the review time on very large or complex projects for quality assurance. Please allow additional time for processing plans due to incomplete submittal information, shipping time, exceptional workload, etc. Special fees may apply for preliminary reviews.



## II. EXPEDITED SERVICE

- Expedited fire protection and building plan reviews are normally completed in up to 5 business days. Inspections will be scheduled as soon as possible, if applicable.
- Add 100% to the base plan review fee including inspection fees, if applicable.
- Plan review letters will be returned as outlined in the client's procedures.
- FSCI may need to extend the review time on very large or complex projects for quality assurance.



## III. INSPECTIONS

- All fire protection inspection fees include:
  - ❖ Examples of inspections:
    - Sprinkler or underground hydrostatic test
    - Sprinkler main drain test
    - Fire alarm system 100% system acceptance test - all devices
    - Suppression gas system discharge test
    - Room integrity test
    - Wet chemical system discharge test

- FSCI requests 72 hour notice for inspections.
- Additional inspection fees apply when the number of inspections needed exceeds the number of inspections paid for.
- FSCI reserves the right to charge additional inspection fees for exceptional, large, design build, phased construction, or special projects at \$120.00 per hour. Saturday and off-hour (before 8:00am or after 5:00pm) rates are \$180.00 per hour. Sunday and holiday rates are \$220.00 per hour.
- Minimum inspection fee is \$175.00.
- Refunds or credits will not be provided for inspections that are not used.

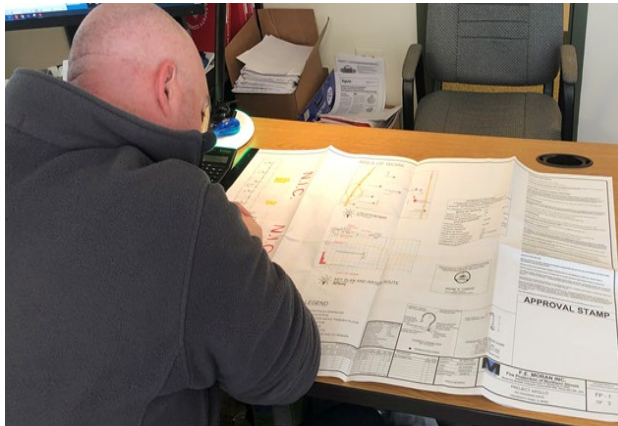
